LCD (LiveCamDesire.com) is welcoming any performer 18 years of age or older (21 in some countries) to join our adult live chat community. You can make a great income and a lot of new friends. However, with this comes some responsibility too LCD (LiveCamDesire.com) wishes to make it clear from the beginning that we do not require from you anything out of the ordinary. Here are our MODEL TERMS & CONDITIONS:

1. Accepting this agreement you certify under penalty of perjury that you are providing us upon registration as a chat host with a real state issued picture ID showing your name, age and/or date of birth (this may vary from country to country). You must be at least 18 years old.

4. You are strictly forbidden to make any derogatory statements about other performers or customers in free or paid live chat.

6. You are completely forbidden to have any other person showing up on your webcam unless they previously sign up and have been approved by LCD (LiveCamDesire.com). That includes and is not limited to family, husbands, wife's, friends....etc.
